Discussion centered on the concept that any federal stimulus dollars should be spread over various projects as discussed by the Council previously, completing the projects in an orderly fashion, rather than selecting one project to

receive all the money. Council members felt a priority list of needed projects should be established and then determine how to pay for such, including utilization of federal money along with General Obligation bonds.

Bob Zimmerman, City Engineer, explained that the question before the Council is whether to accept the ARRA funds and do the projects the State has identified to fund, or give the money back. Before, when the City received state or federal funds, it could be spread over several projects. However, this time, Mn/DOT decided which projects, approved by the Council, would receive the ARRA funds. This project is just to go out for bids on the Center Avenue Bridge and the decision needs to be made now to get it into the construction timelines. If the Council doesn't approve this use of the stimulus funds, they will be returned to the State to use for other Minnesota projects.
